12.	Third Party Insurance liability shall not be less than Rs.100,000.00. Please attach a description explaining the settlement policy of third party liabilities. If not attached the bid shall be rejected.		
13.	The Bidder shall attach a list of government /private institutions who obtain the insurance service of the bidder. With the number of vehicles in the vehicle fleet of each institute.		
14.	The selected insurance company shall have 24 hours call facility.		
15.	Preference will be given to insurance companies who provide towing facility for accidented vehicles, to carry the vehicle to the nearest Police station & to a repair garage.		
16.	On-the –spot inspection for the accidented vehicles shall be arranged. However call & go facility shall be provided for officer's vehicles on the request of the officer using the vehicle, subject to forwarding the vehicle for inspection latter.		
17.	The bidder shall have a proper network of service points to cover any area of the country and onsite assistance should be given within an one hour.		
18.	The bidder shall have been registered for Motor Insurance under Insurance Regulatory Commission of Sri Lanka (IRCSL) & the certified copy of the license shall be submitted with the bid.		
19.	The successful bidder shall submit insurance policy documents which describes all terms & conditions relevant to motor insurance claims in all three languages Sinhala, Tamil, & English.		
20.	For comprehensive insured machinery, any deduction should not be done in payment of claims, as a compulsory reduction.		

21.	If the vehicle is not older than 03 years, full payment shall be done for airbags replacements, for the first time. After that 50% of the replacement cost should be paid for consequent replacements.		
22.	When a vehicle is damaged due to an accident, explain terms & conditions in providing a replacement vehicle or payment of a rental till the repairs are completed.		
23.	When repairs are completed of an accideneted vehicle, immediate action shall be taken to arrange after repair inspection & make payment to release the vehicle.		
24.	The bidder shall have experience in providing insurance coverage for at least three (03) vehicle /machinery fleets which comprises a total number of vehicles/ machinery not less than 200 numbers, per each vehicle fleet of government owned or private institutions. Submit proof documents with the bid.		
25.	It is required to submit documentary evidences that the bidder has been continuously awarded during last three years for fleet insurance from minimum three companies. (Each company should have minimum 50 vehicles in their fleet.).		
26.	The bidder shall have strong financial stability to pay accident claims & annual Turn Over of Motor insurance of the bidder shall be above Rs. 500 million. The bidder shall submit audited financial statements certified by a Chartered Accountant for past three (03) years. Preference will be given to bidders who have strong financial stability with international recognized ratings with regard to financial stability for last 03 years.		
27.	There may be accident cases for which the vehicle cannot be produced for after repair inspection, within prescribed time period, for same special reasons. But the successful bidder should pay claims for accidents of vehicles which occur during contract period ignoring such conditions, although the contract period expired.		
28.	Due to any delay to submit documents relevant to an accident claim, the selected insurance company shall notify to CMC, before closing the claim file. and should pay insurance claims for accidents which occur during contract period although the contact period expired.		

29.	Insurance company shall notify to CMC before closing the claim file, and should pay insurance claims for accidents which occur during contract period although the contact period expired.		
30.	In case the relevant bid value of the items for which expected to submit the bidding documents exceed Rupees five (5) million ,the registration certificate obtained from the public contracts registrar (PCR)Colombo by the representative agent, Sub Agent or nominee/nominated representative for and on behalf of the Bidder should be submitted. If the bidders are not submitted above document Bid will be rejected.
