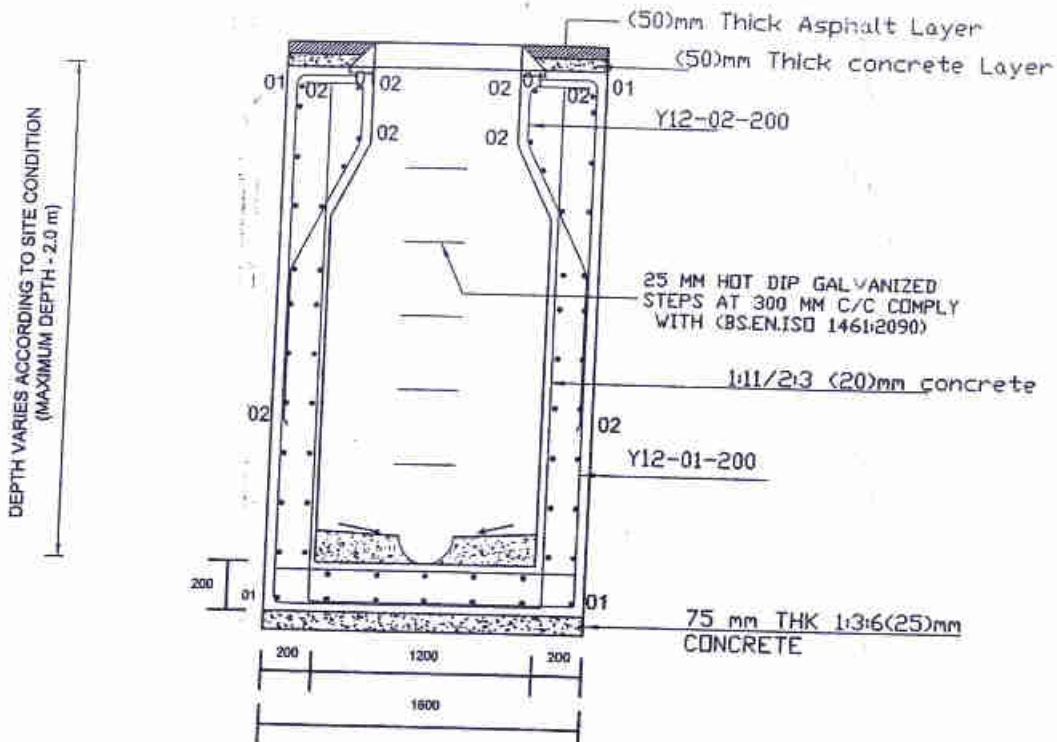

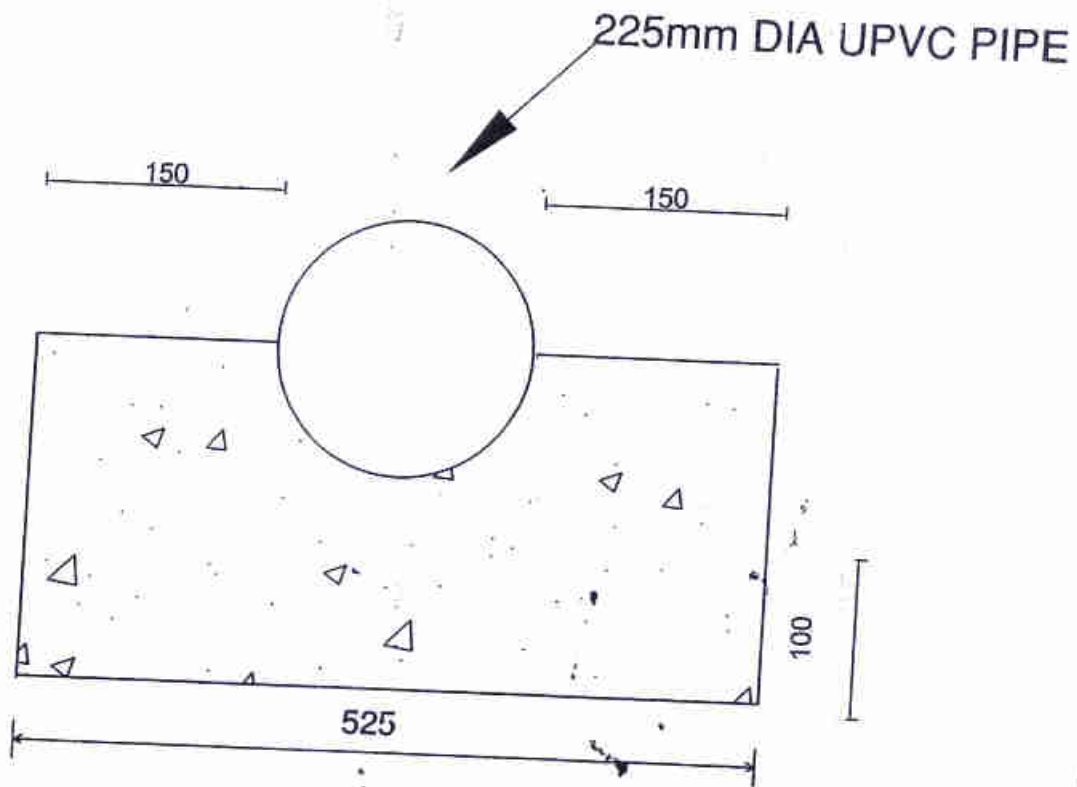


PLAN
