01	<p><u>Instruction to bidders</u>            Clause 2.1 (v): “The contractor has to provide yearly report from a recognized Structural Engineer by the Institution of Engineers, Sri Lanka for the stability, safety and the durability of each bus shelter structure within first three months of each contract year.”            Clarification: Doesn’t the CMC mean the Structural Engineers report for stability, safety and durability be submitted for Bill Boards and not for Bus Shelters?</p>	Richardson Outdoor (Pvt) Ltd	It should be corrected as “The contractor has to provide yearly report from a recognized Structural Engineer by the Institution of Engineers, Sri Lanka for the stability, safety and the durability of each <b>Bill Board structure</b> within first three months of each contract year.”
02	<p><u>Instruction to bidders</u>  <u>Clause 6.5</u>            All Potential Bidders must be informed that revenue-generating accessories such as, advertisement panels, and light boxes, currently installed by Richardson Outdoor Pvt Ltd, will be removed and only the bill board structure, bill board panel will be handed over without the ad panel.            Further, power connections are owned and paid by Richardson Outdoor Pvt Ltd, and the CMC has to advise the successful bidder/s to negotiate with RODL for a smooth transfer of the power connections to the successful bidder/s.</p>	Richardson Outdoor (Pvt) Ltd	<p>The structure of the Bill board shall be as it is indicated in the tender documents. 05	<p><u>Instruction to bidders</u>  <u>Clause 23.1</u>            “Subject to clause 23.2 and clause 24, the employer will award the contracts to the bidders whose bids have been determined to be substantially</p>	Richardson Outdoor (Pvt) Ltd	Yes

06	<p><u>Instruction to bidders</u> <u>Clause 23.2 (b)</u> “Record of poor performance in previous contracts, such as abandoning the works, inordinate delays resulted in payment of liquidated damages up to the maximum limit specified in the contract etc”</p> <p>Clarification: Is the clause only applicable if the bidder has non-performance/ poor performance with the Colombo Municipal Council, or is this applicable to other government agencies as well?</p>	Richardson Outdoor (Pvt) Ltd	Applicable only for Colombo Municipal Council
07	<p>Since the contract with Richardson Outdoor Pvt Ltd is valid and under the execution, in those circumstances although the bid document states a period of 03 years, when does the CMC plan on commencing this 03-year period?</p>	Richardson Outdoor (Pvt) Ltd	Successful Bidder shall commence the work on or before 21 days from the date of letter of acceptance.
08	<p><u>Conditions of Contract</u> <u>Clause 7.2</u> “Under any circumstance structure of the bus shelter or advertising panel should not be used for any other purposes of advertising or campaign.”</p> <p>Clarification: Doesn't the CMC mean to refer to Billboard structures and not Bus Shelters?</p>	Richardson Outdoor (Pvt) Ltd	It should be corrected as “Under any circumstance structure of the bill board or advertising panel should not be used for any other purposes of advertising or campaign.”
09	<p>Conditions of contract Clause 14: Can a successful bidder sign an agreement with advertising companies to market the bill boards, or is that considered as unauthorized subletting? Is giving out advertising space to advertising agencies considered as unauthorized subletting? Advertising is predominantly sold through advertising agencies as they manage the overall advertising budget for companies, therefore if this clause is not amended, this project can not be executed. What "areas of payment" is being referred to?</p>	Richardson Outdoor (Pvt) Ltd	<p>Subletting is not allowed.</p> <p>Areas of payment means areas of annual rental payable to the CMC.</p>
