Invitation of sealed tenders for renting the meat stalls in public markets of the Colombo Municipal Council as the attached schedule for 3 years (2024/2025/2026.)

2. Issuance of tender applications

Tender Documents (original and duplicate) could be obtained by two methods between 9.00 a.m. and 3.00 p.m. from 04.10.2023 until 24.10.2023.

Method 0 1 - Obtain from Town hall head Office

- ❖ Tender documents may be obtained from the revenue branch, Municipal treasurer's department, Colombo Municipal Council, Colombo 07 on submission of written request upon payment of the application fee of Rs.5,750.00.
- ❖ Method 02 Download from the official website of CMC www.colombo.mc.gov.lk.
- **I.** Non refundable application fee of Rs 5,750.00 can be paid in following two methods.
 - a) From any People's bank branch to be credited to **Account No.** <u>167-1-001-6-</u> <u>3169425 maintained at the Townhall branch People's Bank.</u>
 - b) At the payment counters of the district office premises withing the limits of the CMC on weekdays from 9.00 am to 3.00 pm.
 - c) Tender deposit should paid in cash to the revenue Branch of the Municipal treasurer's department.
 - d) It is mandatory to attach the original receipt of payment with the tender document.

Tender opening

- 1. Accepting the tender deposits will be closed at 3.00 pm of 25.10.2023 and duly perfected applications consisting of sealed original and duplicate should be deposited in the tender box placed at the Municipal Secretary's Department, Townhall Premises, Colombo 07 before 10.00 a.m. on 26.10.2023.
- 2. Acceptance of tender application will be closed at 10.00 a.m. on 26.10.2023. and will be opened immediately thereafter. Authorized representatives are permitted to be present at the time of opening of tenders.
- 3. Further details regarding this may be obtained from the Deputy Municipal Treasurer (Revenue) (011-2692465)

3. Instructions for filling application

- 1. Full name and address which is mentioned in NIC should be written in the tender application.
- 2. The minimum tender amount for each store is given from page 04-06 of the schedule.
- 3. The prescribed application should be completed using a black or blue carbon pen.If correction has to be done the word should be crossed out with a single line and short signature should be placed there. Do not use pencils and tipex for any reason.
- 4. The tender amount should be mentioned both in <u>numbers and letters.If there is any</u> <u>discrepancy between the numbers and letters</u>, the amount mentioned in letters will be accepted as the tender amount.
- 5. Each tender document should be completed and signed by the tenderer himself/herself.
- 6. Original copy and Duplicate copy of Tender Document should be placed in separate envelops. After that those two envelops should be placed in one envelope, <u>and sent to the Municipal Commissioner</u>, Colombo <u>Municipal Council</u>, <u>Townhall</u>, <u>Colombo 07 by registered post or Can be placed in tender box at the Municipal Secretariat Department</u>.
- 7. **The store number and the market name** should be mentioned on the upper left corner of the envelop. Tenderer's name and the address should be mentioned on each envelop.
- 8. The following documents should be submitted along with the application.
 - 1. Original receipt of Tender deposit.
 - 2. Original receipt of Tender application fee.
 - 3. A document to confirm the tenderer's address.
 - 4. A photocopy of the National Identity Card.

4. Evaluation of tenders

- 1. The tender for each store will be offered to the highest tender amount.
- 2. Incomplete applications will be rejected.
- 3. Tender deposit amount for each stall, which is mentioned in the schedule of application Should be paid in cash and the original receipt should be attached to the tender application. Any breach in this will be a case for rejection of the application.
- 4. The applications of persons who has violate the tender conditions of CMC previously, will be rejected. And any tender submitted in violating tender conditions will also be rejected.
- 5. The council reserves the right to reject any tender application if it is found that this tender is not submitted with bona fide intention. If the council decides character and practices of the tenderer does not fulfil the aim of the council the application will be rejected. In such occasions council is not bound to provide reasons to the rejection.
- 6. The council has the final decision to accept or reject any tender and all matters are bound to it .

5. Award of tender

- 1. Whether the submitted tender is successful or unsuccessful will be notified in writing.
- 2. The first installment amount should pay within 07 days after being notified as the successful tenderer. And should pay Rs 50,000.00 electricity /Water Security deposit and slaughter license fee of Rs.100.00 (excluding chicken shops) to the Colombo Municipal Council.
- 3. All persons who have submitted their valid tenders in strict compliance with the requirements of this notice, but have not accepted their tenders before the end of tender acceptance are entitled to get back the deposit given for the tender.
- 4. <u>If a successful tenderer does not accept the tender, he will not be entitled to</u> refund of the deposit.
- 5. The tender deposit of those who leave the shop first before the end of the tender period will not be refunded for any condition or reason.
- 6. To get back this deposit amount, it should be requested <u>within 06 months after</u> <u>opening of tender.</u> All unclaimed deposits within that period will be credited to the revenue, and subsequent requests for refund will not be considered.
- 7. The following documents should be submitted for refund of this amount.
 - **1.** A letter requesting refund of the deposit.
 - 2. A copy of the deposit payment receipt.
 - **3.** Photo Copy of National Identity Card.
 - **4.** A copy of a pass book or a copy of a bank statement containing the tenderer's bank details.
- 8. All problems and losses arising out of delay in opening the shop after payment of the tender deposit shall be borne by the tenderer and the tender amount shall not be refunded in the case of a shop not opened for any reason whatsoever.

6. Payment of installments

- 1. The tender value for the year should be fully paid in two equal installments, first installment before 31st December of the previous year and second installment on 31st March of the relevant year. In the 2nd and 3rd years, tender amount will be calculated with 5% additional amount for previous year's tender amount and rounded it in to the nearest thousand.
- 2. If this date (31st of the relevant month) falls on a holiday, it must be paid on the last day of duty or the earlier. If the payment of installments due on the relevant date is not made, the shop will be sealed on the 1st of the next month and the tender deposit held for the shop will also be credited to the revenue.
- 3. Meat stalls which not obtain the direct electricity and water supply, should pay Rs 12000.00 for Electricity and Rs. 5000.00 for water monthly and it should pay to the municipal veterinary department on or before 15th of each month. Once in 03 months, Electricity and Water bills of all meat stalls should be settled and copies thereof should be submitted to the Market Supervisor to confirm that the electricity and water bills have been paid. If not, the relevant meat stall will be sealed immediately.

7. General conditions

- 1. The council reserves the right to impose any conditions required by the tender and from time to time and the tenderer will be bound by the additional conditions so imposed.
- 2. The tenderer shall adhere to such requirements and conditions as may be decided by the Council from time to time.
- 3. Before submitting the tender, the tenderers are expected to have an understanding of the physical condition and other facilities of the store where they are tendering and the condition of the market where they are tendering.
- 4. Tenders should be submitted with a clear understanding of the existing condition after physically inspecting the store. Repairs at the shop must be carried out by the person receiving the shop.

5. The tenderer shall not be entitled to apply for refund of tender money or repair costs or

revision of rent or any other form of compensation or reduction of damages or expenses

for any reason after signing the contract.

6. If the courts have found him guilty of any offense under the by-laws of the council, the

Consumer Protection Act or any relevant law while trading in the markets given to him,

the transfer of rent made by such a person will be cancelled.

7. An assignment made to any tenderer is non-transferable and shall not be given to any third

party for any reason.

8. By the tenderer in preparation of his market tender or as a result thereof the Council shall

not be liable for any expenses incurred by the tenderer.

8. Special facts

Awaiting submission of tender documents and having decided not to submit tender

documents after payment of tender deposit, tenderers who do not submit all the tender

documents including the deposit receipt before the closing of are entitled to get back the

tender deposit.
