Vacancy Notice

Recruitment for the post of Fireman in the Fire Service of Colombo municipal Council in the Western Province Public Service – 2018.

Applications are invited from the permanent male residents of the Western Province for the recruitment to the post of Fireman in the Fire Service lying vacant in the Colombo Municipal Council.

Applicants should prepare applications in A4 size paper according to the specimen given below by typing or in clear hand writing in both sides of the paper and should send by Registered post addressed to **“Municipal Commissioner, Municipal Commissioner’s Office, Colombo Municipal Council, Town Hall, Colombo 07”** to reach on or before 15.11.2018 on the left hand corner of the envelop where the application is enclosed the words **“ Application for the post of Fireman in the Fire service of the Colombo Municipal Council in the Provincial Public Service (WP)”** should be written and the applications received after 15.11.2018 will not be considered.

1. Title of the post – Fireman in the Fire Service of the Western Provincial Public Service.

- I. Monthly salary scale – Public Administrative Circular 03/2016 – Rs 1- PAC 03/2016
29540 – 7 x 300 – 27 x 370 – 41,630/=
(Salary is paid according to the schedule 02 of the Public Administration Circular 03/2016)

- II. This post is permanent and pensionable. You should be subjected to the policy decisions taken by the government in future regarding the pension scheme applicable to this post.

(4) Qualifications applicable to the post :

- (I) Should be a citizen of Sri Lanka.
- (II) Should be a permanent residence in the Western Province for a period of 03 years prior to the closing date of application
- (III) Should be unmarried.
- (IV) Should possess an excellent moral character and should be confirmed by a police report that he has not been involved in any illegal activity.
- (V) The qualifications stipulated in the notice of calling application for the recruitment to this post should be completed in all aspects.
- (VI) Should have passed in 06 subjects with four credit passes including Sinhala/Tamil language and Mathematics at the G.C.E (O/Level) Examination at one sitting and should have passed Science and English language at the same sitting or one more optional sitting.
- (VII) The height of the applicants should not be below 162 cm and BMI should be duly existed. (Body Mass Index Should be between 18.5 – 24)
- (VIII) Every applicant should be physically fit to work in the duties of the post and in any area of the island.
- (IX) Eye sight requirements – Eye sight should be between 6/6 and 6/12 without glasses or contact lenses and the colour sight should be normal.
- (X) No any artificial physical changes (like tattoos)

(5) Age limit

Should not be below 18 and over 24 years of age.

(6) Scheme of Recruitment.

Will be selected as Apprentice Fireman for the vacancies according to the order of the marks obtained by written test and vocational (practical) test.

- I. Before the commencement of the training, all the apprentice Fireman will be subjected to a medical test to ensure the physical, mental fitness.
- II. The persons who are selected for the vacancies have to follow one year fire training course. Appointing Authority has full power to terminate the training of those trainees, whose conduct is found to be unsatisfactory and of those trainees who are unable to achieve the expected performance standards during the training period, without compensations.
- III. The apprentice Fireman who completed the relevant training successfully will be recruited for the post of Fireman. Training period will be calculated for the permanent service and will be placed in the 2nd step of salary scale when instated in the service after the training period.
- IV. A monthly allowance of Rs. 10,000 will be paid during the training period.
- V. Permission will not be granted for any apprentice Fireman to get marry during the training period.
- VI. The selected apprentice Fireman should serve for 5 years continuously in the Western Provincial Public service upon successful completion of the training programme and to this effect trainees should enter into a bond of Rs. 500,000/= (Five hundred thousand) with the relevant local government body.
- VII. If the apprentice leave during the training period at his discretion, all the expenses incurred for the training should be paid to the institution.
- VIII. It can be directed for those who are appointed to the post of Fireman to reside in the administrative limits of the relevant Local Government Institution.
