On behalf of the Colombo Municipal Council , Municipal Commissioner invites sealed tenders from eligible and qualified tenderers for **Erection and maintenance of non illuminated advertising panels at selected locations within Colombo city, owned/ maintained by Colombo Municipal Council .** (Places shall be described as Annexes 01)
2. The scope shall be erection and maintenance of on Road advertising locations (Hoarding) in the city of Colombo (Leasing out of on road side advertisement locations in the city of Colombo)
3. Tendering process will be conducted through procedure adopted as per tendering document.
4. To be eligible for contract award, the successful tenderer shall not have been blacklisted and shall have remarkable experience in similar type of work.
5. Qualification requirements to qualify for contract award include:
 - a. Average annual volume of advertising work performed in the last 5 years shall be Rs. 500,000.00 x No. of advertising panels requested by the tenderer. Each tenderer shall submit proof documents to justify at least the same amount.
 - b. Tenderer shall have experience of at least 03 of similar work within past 5 years. (Documents to verify projects awards, completion certificates, certificates on successful on-going projects etc. shall be submitted along with the tender).
 - c. Tenderer shall have minimum amount of liquid assets and/or credit facilities not less than Rs. 500,000.00 x No. of advertising panels award to the tenderer (If awarded). Each tenderer shall submit proof documents to justify at least Rs. 500,000.00 X No. of advertising panels quoted for liquid assets/credit facilities. (copies of proof documents shall be submitted with the tender).
 - d. Tenderer shall assign a qualified Management staff for the project for planning design and implementation phase from stage of tendering and implementation to deal with operational and managerial functions as per the satisfaction of the client.

- ❖ The Contractor shall submit updated condition report in every three months' time for the advertising committee for review and any violation against the by law or the agreement shall be notified the contractor and the contractor is bound to remove such advertisement without any cost to the council with immediate effect.
- ❖ The advertising panels are located within the Right of way and in case of necessity to remove them in future development considering the highway geometric alterations or for the purpose of implementation of traffic management systems the Municipal Commissioner shall have the right to remove them accordingly.
- ❖ The structural stability of the advertising panels shall be maintained throughout the contract period and initial and annual report on structural stability of each panels shall be submitted with the certification of a qualified structural engineer.

The contract price is **not subjected to any adjustment**. In case of situation arising out of national disaster ,crisis , pandemic or any other situation declared as national disaster and contribute for justifiable loss of income is proven shall be considered by the Evaluation committee appointed by the Municipal Commissioner comprising five members ,and two of them are the representative of the advertising committee and the other three shall be included with an accountant .The report and recommendation of the committee shall be submitted for General council for approval.

The performance security shall be **50%** of the Initial Contract Price. This security shall be unconditional on demand and valid till 28 days beyond the intended completion date or any extended intended completion date. Contractor shall extend the validity of performance security for any extension of intended completion date without any notification by the employer. Employer shall demand the performance security for such failure of the contractor to extend its validity without any notification to the contractor.

Erection and maintenance of non-illuminated advertising panels at selected locations within Colombo Municipal Council owned/ maintained locations in Colombo shall be a revenue contract with open and fair competition while allocation of public property expecting a return payment. The allocation of public assets includes monetary returns, social objectives and national interest while maintaining the transparency. The Colombo Municipal shall grant of the possession of property of advertising for a period of 03 years in return expecting a revenue payment in substitution of annual rent of ground and the hoarding structure.

1	Tenders should be submitted by reputed Local Agents / Dealers who have previous experience of completing at least 03 (Three) contracts during last five years in the advertising field.
2	Qualify for contract award, a tenderer shall have at least liquid assets/credit facilities worth of, Rs. 500,000.00 x No. of advertising panels requested by the tenderer. So it is advisable for each tenderer to submit proof documents to justify at least Rs. 500,000.00 X No. of advertising panels quoted for liquid assets/credit facilities.

Tender Deposits.

Payments of tender deposit should be made by Cheques, Cashier's Orders, Banker's Guarantees or other equivalent electronic instruments. Failure to pay the tender deposits due to factors such as dishonored cheques and stoppage of cheque payments will be treated as a disqualification from tender as the tenderer has not fulfilled the conditions of tendering.

Qualification Criteria

The following qualification criteria shall be applicable for all tenderers in submission of the tender and Same shall be considered for the evaluation .

1. The eligible Tenderer to submit tender are companies firms, individuals possessing a valid business registration certificate for the purpose of advertising.
2. The scope of this tender is to undertake erection and maintenance of non illuminated advertising panels in identified locations in Colombo. Contract period shall be 36 months from the date of Letter of Acceptance.
3. Tenderer shall quote an annual rental fee payable to Colombo Municipal Council for each location in the Form of tender. A tenderer can quote for one or more locations in the Form of Bid as per Tenderer's choice. Tenderer can only quote in the Form of Tender issued with the tendering documents. Tenderer shall verify the exact locations prior to tender.
4. To qualify for contract award, a tenderer shall have at least a liquid assets/credit facilities worth of Rs. 500,000.00 x No. of advertising panels award to the tenderer (If awarded). So it is advisable for each tenderer to submit proof documents to justify at least Rs. 500,000.00 X No. of advertising panels quoted for liquid assets/credit facilities.
5. Non submission of any of above shall be considered as rejected.
6. The Tenderers are defaulted in rental payments in previous contracts with Colombo Municipal Council, will not be considered in the tender evaluation.

Evaluation Criteria

1. Tenders shall be evaluated by a Technical Evaluation Committee appointed by Municipal Commissioner and evaluation shall be mainly based on eligibility and qualification of tenderers as mentioned in above 1 to 5 and highest tender value. Municipal Commissioner has the right to annual the bidding process any time before the award of contract without any notification.
2. The tenders less than the 80% of the valuation of the employer (Minimum rate schedules) shall be rejected.
3. Each tenderer shall submit a tender security worth of 50% of quoted sum of bid excluding taxes. This tender security shall be on demand unconditional guarantee and obtained from a reputed Bank or Insurance Company. This guarantee will be forfeited if any tenderer withdraws his tender after closing of tenders; selected tenderer refuses to sign agreement with Colombo Municipal Council or fails to submit Performance security and sign agreement within 28 days of the date of Letter of Acceptance. Any tender not accompanied by the tender security will be rejected.
4. The tender shall be valid up to **25th March 2022**.

Contract Conditions

Erection and maintenance of non illuminated advertising panels at selected locations within Colombo Municipal Council owned/ maintained locations in Colombo

1. Selected contractors shall enter in to an agreement with Colombo Municipal Council on agreed terms and conditions to cover the whole scope of work within 28 days of the Letter of Acceptance.
2. Selected contractor shall produce an on demand unconditional performance security in the form of a guarantee from an acceptable commercial bank at the time of signing agreement. Value of the guarantee shall be 50% of contract sum except taxes. Contractor shall maintain the validity of said guarantee for the whole period of contract and one month more beyond. In case when contractor refuses to duplicate the work of unacceptable standard at contractor's cost and/or abandoning the work/refuse to undertake any entrusted work and/or fail to perform work due to any other reason and/or violate any condition in the signed agreement, action will be taken to forfeit the performance guarantee. If contractor's performance security is demanded, it will be a disqualification for further advertising projects in Colombo.
3. Installed non illuminated advertisement panels will become a property of Colombo Municipal Council at the end of the contract period of 3 years. Contract period is begun effective from the date of Letter of Acceptance.
4. Contractor shall pay rental applicable taxes for each panel within 1st month of each year of the contract.
5. Entire cost of installing panels including trenching permits or any other requirement and cost of maintenance of each panel through the contract period shall be borne by the contractor. Contractor shall use already installed panels at these locations if any.
6. Contractor will be given the opportunity to sell advertising through these panels.
7. Contractor shall install the non illuminated advertising panels within 1st month of the date of Letter of Acceptance to an acceptable quality in appearance and strength. Contractor shall submit a certificate from a chartered Civil Engineer on structural strength and stability of each panel.
8. Contractor shall maintain non illuminated advertising panels throughout the contract period to acceptable standard.
9. Ground level non illuminated advertising panels shall be of rectangular in shape. Horizontal length of each panel shall be limited to 20 feet and vertical length of each panel shall be limited to 10 feet. Height above the ground level to pole. Municipal Commissioner may consider little changes for specifications for locations above the ground level installation.
10. Installation, maintenance and display of these panels are governed by the relevant clauses of extraordinary Gazette number 1713/10 of the Democratic Socialist Republic of Sri Lanka.
11. Contractor shall not claim any damages that will happen third parties during construction and entire period of maintenance. Contractor shall indemnify Colombo Municipal Council from such claims. It is

the responsibility of the contractor to maintain suitable insurance policies to compensate any damages to his/her own personnel, machinery, equipments, tools etc. and other properties/ employee's personnel, machinery, equipments, tools and other properties and all other types of third party damages that might happen during construction and throughout the contract period.

12. Municipal commissioner has the right to remove any of these panels, when necessary, at any time without notifying it to the contractor for unavoidable circumstance. Contractor has no right to claim any damages from Colombo Municipal Council for such an event. Municipal Commissioner may consider allocating a different location for such an incident.

Monitoring and control of Payment

1. The municipal Treasurer shall monitor the revenue collection applicable by the department and necessary notices shall be issued when necessary. The annual payment shall be made in the first month of each year. In case of failure to made the payment shall be informed to the contractor by the Municipal Treasurer as per the provisions in the agreement. There shall be two intermediate notices before the final notice. Time between each notice shall be 14 days.
2. If an appeal is not made by the contractor requesting for a grace period for payment including areas within a period of one month from the final notice it shall be considered by the Municipal Treasurer with the concurrence of the Municipal Commissioner.
3. The acceptance of the municipal commissioner for above request shall be informed to the contractor giving a time period for payment.
4. The contract shall be immediately terminated in violation of above notice as per the provisions of the agreement.

Breach of Contract

For any breach of contract by the contractor , such as unauthorized conversion of use, unlawful or unauthorized activities, and unauthorized sub-letting, and areas of payment beyond and as described above shall be treated as breach of contract. The municipal Commissioner shall inform the contractor of such events in writing .

Termination of contract

The sufficient notice shall be given for the breach of the contract, in accordance with the agreed terms and conditions as per the agreement. Finally, the letter of termination shall be issued with the concurrence of the council. Any loss arising out of any condition leading to breach of contract shall be recovered from the performance security provided under condition of contract.
