3. Storm Water Drainage Contractors of **CIDA C** grade.
4. Aluminum & Finishes Contractors of **CIDA SP/F** grade.
5. Floor (Roads) Finishes Contractors of **CIDA SP/F** grade.
6. Landscaping Contractors of **CIDA SP/F** grade.
7. Electrical Installations (Low Voltage / Medium voltage) Contractors of **CIDA EM** grade.
8. Waterproofing Contractors of **CIDA SP** grade.
9. Contractors of Supplying & Installing monumental sculptures (of Marble , Granite , Terrazzo, Concrete etc.) **CIDA** grade is not necessary.

Those who submit Applications shall possess a valid registration in Construction industry Development Authority (**CIDA**) at no. 123 Wijerama Mawaha, Colombo 07. (For 01 to 08 above) And a valid business registration certificate Colombo Municipal Council has the right to call tenders from the registered Contractors up to Rs. 50,000 under shopping procurement category as per Standard By-Laws of Colombo Municipal Council of the Extraordinary Gazette Notification No 2245 / 30 dated 17.09.2021 part v 3 (a) and 3 (b) tender procedure. However, when necessary to enhance competitiveness, Colombo Municipal Council always has the right to go on open Tenders in newspapers for projects of any value.

Relevant application forms could be purchased on a request made on a business letter head from the Projects Management Division of Municipal Engineer's Department at town hall, Colombo 07 or down load from CMC website on a payment of Rs.1080.00 (inclusive of **VAT**) in cash as non-refundable form fee. Fee of registration of Rs.2000.00 for each Category will be levied in advance and a Photocopy of the receipt of payment shall be submitted along with the Application. The registration fee will be refunded to the applicants who will be disqualified for registration. Applications will not be issued for Contractors who have been declared as defaulters by Colombo Municipal Council.

Duly filled application forms along with the supporting documents shall be posted under registered Cover to Director Engineering (Projects), Colombo Municipal Council, Town Hall, Colombo 07. To reach the office on or before 31 of March 2022 "Registration of Contractors for the year 2022" shall be written on top left-hand corner of the sealed envelope.

Applicants will be called for an interview to verify the details mentioned in the Application Originals and true copies of all the certificates / documents supporting the Application shall be Submitted at the interview.
