BED AND HAUNCHING DETAIL

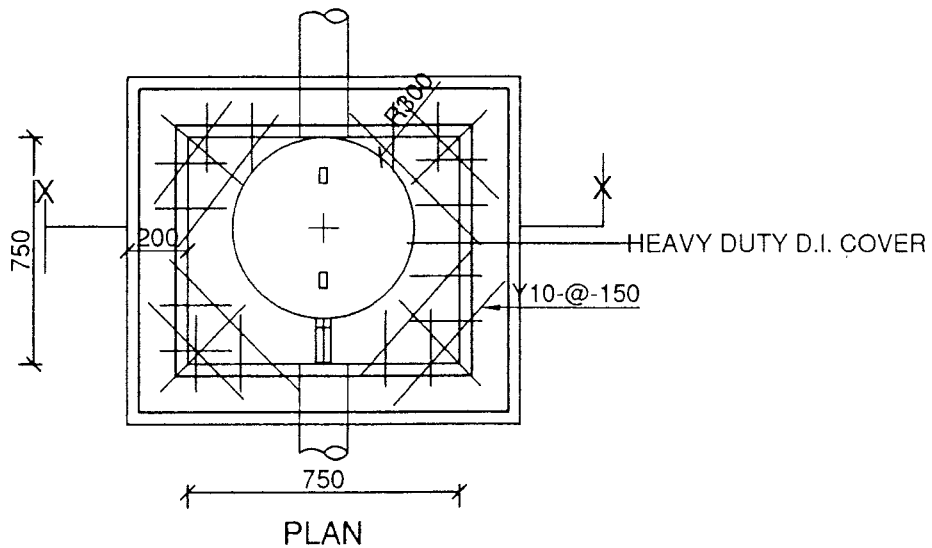

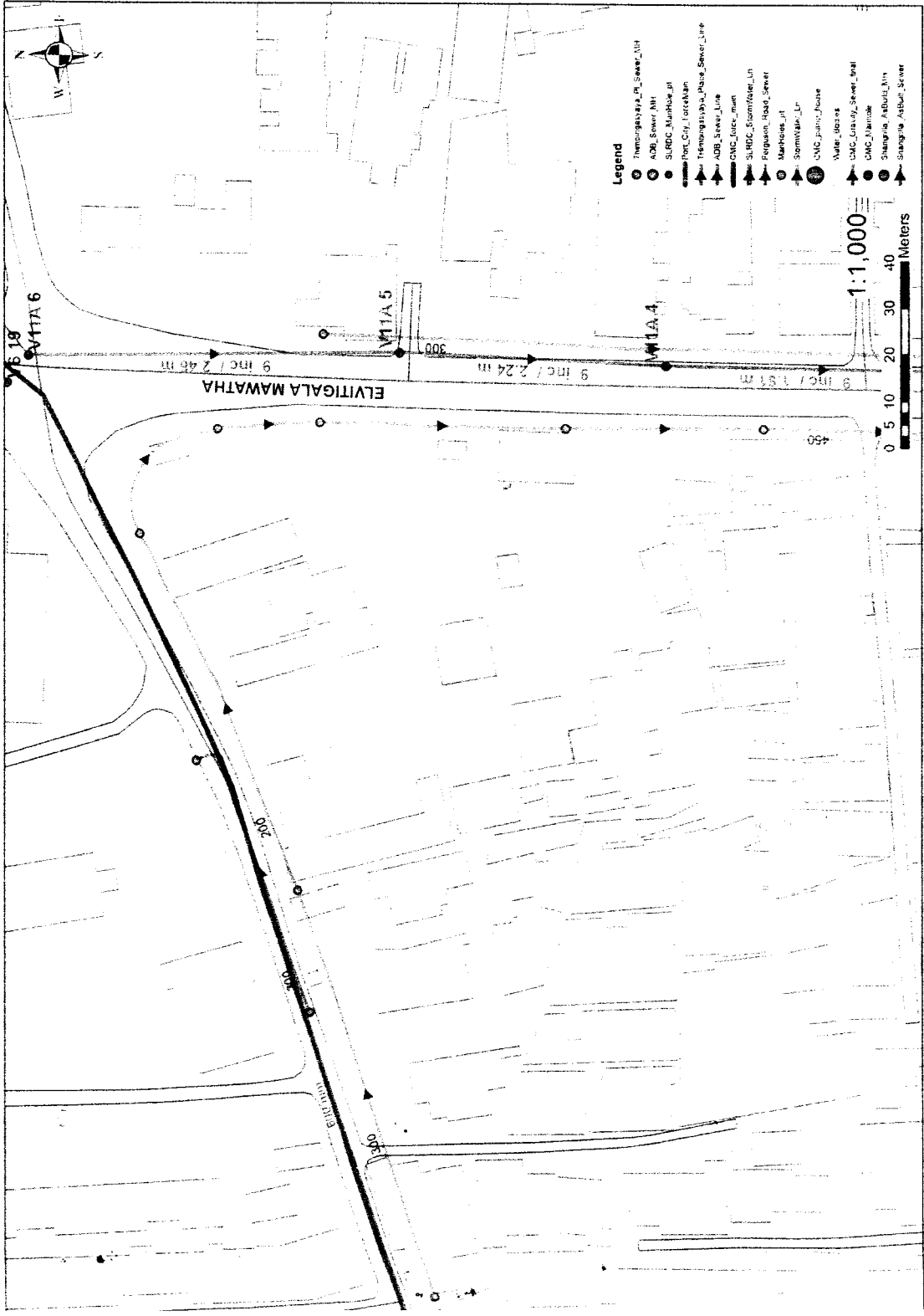

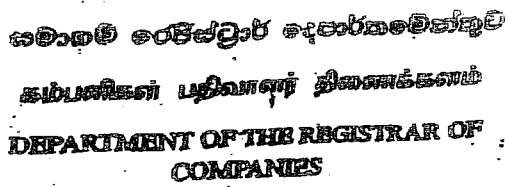
