- Duly perfected sealed applications containing the Original and Duplicate should be deposited in the Tender Box kept in the Municipal Secretary's Department in Town Hall premises, Colombo 07 to receive before **10.00 a.m. on 22.05.2025**.
- Receiving of applications will be closed at **10.00 a.m. on 22.05.2025** and tenders will be opened immediately thereafter. Authorized representatives are permitted to be present at the time of opening of tenders.
