DRAWING TITLE: STORM WATER MANHOLE 600MM X 600MM (SINGLE RAINFORCED)










DRAWING TITLE: SEWER MANHOLE 600MM X 600MM (SINGLE RAINFORCED)












DRAWING TITLE: STORM WATER MANHOLE 750MM X750MM (SINGLE RAINFORCED)










DRAWING TITLE: SEWER MANHOLE 750MM X 750MM (SINGLE RAINFORCED)









DRAWING TITLE: STORM WATER MANHOLE 750MM X 900MM (SINGLE RAINFORCED)












DRAWING TITLE: SEWER MANHOLE 750MM X 900MM (SINGLE RAINFORCED)








DRAWING TITLE : STORM WATER MANHOLE 1200MM X 900MM (SINGLE RAINFORCED)

DEPTH VARIES ACCORDING TO SITE CONDITION (MAXIMUM DEPTH - 2.0 m)







SECTION 9 STANDARD FORMS (BID)

Note:
