- a. Tender /bidding documents will not be available on the website / issued after 10.00 a.m. on **23/11/ 2021**.
- b. Value of unconditional on demand bid bond / security should be valid till **210 days** from the date of closing tenders / bids. **Bid bond / Security shall be valid till 22/06/2022. Offer should be valid till 23/05/2022. Security deposit in cash will not be accepted.**
- c. The ORIGINAL duly filled sealed tender / bidding document with the DUPLICATE should be deposited in the Tender box kept at the **Municipal Secretary's Department, Town Hall, Colombo 07 on or before 10.00 a.m. on 24/11/ 2021**.
- d. **The Tender / bid will be closed at 10.00 a.m. on 24/11/ 2021** and tenders / bids received after closing time will be rejected and tenders / bids will be opened immediately thereafter. If this day is declared as a Public Holiday, tenders / bids will be closed at 10.00 hrs. on the following working day.
